#### **Narrative**

On 1/7/2020 at approximately 1456 hours Antee, Lindsey came into Records and reported the following:

In January of 2018, Antee, Lindsey filed a report online for forgery being committed using her name. At the time she thought it was her ex husband Antee, Bobby. After filing the report online, she was informed that the report would not be investigated due to it being a martial affair.

On 1/3/2019 at approximately 1500 hours, Lindsey had reported the forgery to the Secretary of State, and through their investigation they discovered that Sikalis-Bott did forge Lindsay's name on the a quit claim deed. After being informed this information, Lindsey made a post on social media stating she would be glad that when everything is over and the secretary of state had taken Sikalis-Bott's journal. On that same day, Lindsey received a response from Sikalis-Bott stating that she did not commit the forgery. Lindsey was sent an email from the secretary of state stating that Sikalis-Bott was out of compliance with them and that she had received a civil penalty. Lindsey posted this message on social media and then blocked Sikalis-Bott from her page.

Lindsey has never met Sikalis-Bott in person. Lindsey believes that Sikalis-Bott forged her name due to changing her mind about purchasing a home. Lindsey also believes that Sikalis-Bott took \$8,000 out of her escrow to help her ex-husband Bobby qualify for purchasing the home with out her permission. Lindsey asked Bobby about the \$8,000 and his response was that the mortgage company took the money.

Lindsey brought in a lot of documentation and will be bringing in more documentation at a later date.
