ORDER

Pro se Plaintiff Lindsey Licari filed the complaint in this action on April 27, 2021. (ECF No. 4.) On May 14, 2021, summonses were issued to the following Defendants: Trevor Atkin, Rob Bare, Clark County District Attorneys Office, Clarkson and Associates, Marquis Aurbach Coffing, Debbie Conway, Jim Crockett, Mark Denton, Cam Ferenbach, Aaron Ford, GLVAR, Mark Gibbons, Elizabeth Gonzales, Gerald Hardcastle, Kathy Hardcastle, Mary Kay Holthus, Rena Hughes, Ronald Isreal, Jennings and Fulton LTD, Eric Johnson, David Jones, Judicial Commission of Nevada, Daryl McClosky, Lenora Muller, Gloria Navarro, Nevada State Bar, Nevada Supreme Court, Angela Ochoa, Ron Parraguirre, Kristina Pickering, Resnick & Lewis PC, Shumway Van LTD, Abbie Silver, Lidia Stiglich, Dawn Thorne, Chris Tillman, and the Las Vegas Metropolitan Police Department. (ECF Nos. 14, 15.)

On May 27, 2021, Plaintiff filed an emergency motion for injunctive relief, which the Court construed as a request to serve Defendants by email. (ECF No. 9.) The Court denied Plaintiff's motion because she did not articulate the nature of the emergency. (ECF No. 10.) More than two months later, the Court issued a notice of intent to dismiss all

1 unserved Defendants¹ pursuant to Fed. R. Civ. P. 4(m) unless proof of service was filed
2 by September 8, 2021. (ECF No. 11.) To date, no such proof of service has been filed.

3 It is therefore ordered that this action is dismissed without prejudice.

4 The Clerk of Court is directed to close this case.
