## SECTION 4: DESCRIBE YOUR COMPLAINT:

I filed a complaint 2 previous times. Pursuant to NRS 205.372 (5), NRS 598D.150 (1) (2) (3) the Attorney General has jurisdiction over Mortgage Fraud. Pursuant to NRS 598D.150 (3) it is not the responsibility of any local Government agency to regulate issues of mortgage fraud, it is the responsibility of the Attorney General. On 1/17/2018 my name was forged to quit claim, in which I have attached that complaint as well. I then followed up several times, with emails and more evidence. The Attorney Generals Office had adequate information to act and failed to do so. Due to the Attorney General not acting, I was put through stalking, harrasment, embezzelment, fraud, while the AG has allowed Nevada Secretary of State to not act against notary Nikki Sikalis Bott who acted as the escrow agent and the notary in the mortgage fraud transaction. This alone revokes the deed, and being that Bobby Antee was part of the Mortgage Fraud Pursuant to NRS 205.0832 1 (a) , NRS 208.085, NRS 205.090,NRS 205.110, NRS205.220 1(c), so has no leagal right as community property pursuant to NRS 205.265 part ownership is not a defense for theft. I reported the Mortgage Fraud to GLVAR, NRED, in which they also took no action which also makes all parties involved that chose to conseal the acts of Bobby Antee, Linda Naw, ERA Brokers, National Title Company, One Realty Group, VALley West Mortgage, Mellissa Parker, Tracy Bouchard, Jeff Moore. I also copied my legal counsel Jennings and Fulton LTD on every email to GLVAR, NRED, SOS, in which they committed Legal Malpractice by allowings these agencies to conseal Mortgage Fraud, which in turn also makes them guilty of Mortgage Fraud Pursuant to NRS 205.372 (a) Shumway Van then litigated on the behalf of my now Ex Husband for 3 years, when on 11/20/2018 Shumway Van counsel of Bobby Antee submitted respondant docs to GLVAR that produced the Mortgage Fraud and proof that Nikki Sikalis Bott Notarized her own document and acted as the Notary and Escrow Agent. National Title Company then allowed Melanie Treanor, Nikki Botts Neighbor to notarized th Deed of Trust slandering Title into Mr. Antee's name. Pursuant to NRS 205.330 Eevery person at the closing who knowingly Fraudulently Conveyed Title is Guilty of Fraud. Pursuant to NRS 205.355 Bobby Antee knowing recieved Fraudulent Conveyance and pursuant to NRS 205.370 (1) Bobby Antee swindled credit, by not disclosing his open child support case in 2017, and was instructed by Valley West Mortgage to lie on his loan application. This is a Category D Felony, yet he has not been arrested nor has Nikki Bott, Linda Naw. Bobby Antee's counsel submitted the evidence of Mortgage Fraud, then friviously filed a complaint on the behalf of Linda Naw knowing that she was clearly part of the mortgage fraud and continued to litigate a divorce, which was a annulment and Lis Pendens. I originally hired Chris Tillman who knew of the mortgage fraud and continued to litigate for his own unjust enrichment and to help conseal the crimes of ERA Brokers and National Title Company. After 6 months of litigating the divorce, I fired Chris Tillman and reported him to the Bar, in which they took no action and continued to let Jennings and Fulton Litigate 3 separate matters over one issue. Jennings and Fulton had one retainer for A-18-786141-C, in which they litigated A-20-808737-C and D-18-573154-D over the same issue but failed to produce the evidence given to them at trial, or in discovery. Logan Willson, Adam Fulton, and Jared Jennings lied to me for 2 years, insisting I had no damages and not advocating on my behalf at all to obtain justice. Pursuant to NRS 205.380 1 (a) are guilty of obtaining money from me with the intent to defraud. Pursuant to NRS 205.390 (1) Linda Naw obtained my signature on gift letters with the promise I would be listed on title as a owner, she failed to list me as a owner so is guilty of NRS 205.395 1 (a). These are all deceptive trade practices pursuant to NRS 598.0903 to 598.0999 which are matters explicitly handled by the Attorney General. Jennings and Fulton then filed A-20-808737-C a year after retaining them and providing them with clear evidence of mortgage fraud. Adam Fulton spent two years threatening me, lying to me, and misleading my cases. Logan Willson was copied on emails to GLVAR, LVMPD, Bond Companies, and refused to represent me honestly. Jennings and Fulton Embezzled \$16k in legal fees, and Shumway Van, Garret Chase, Grayson Moulton, are not trying to extort \$44k in legal fees, with the judicial abuse of Rena Hughes. Pursuant to NRS 205.372 (a) (b) they are all guilty of Mortgage Fraud for their consealment. The Attorney General had all of this information since 6/5/2020 and prior, and failed to act. Pursuant to 205.372 (5) the attorney general should have investigated and prosecuted all parties involved in the fraudlent closing and those who choose to conseal it after the fact. I filed 3 police reports, in which LVMPD has taken to action and has also tried to conseal the Mortgage Fraud, in turn making LVMPD guilty of Mortgage Fraud. Shumway Van and Grayson Moulton continue to harrass me on a daily basis, they have kept my assests trapped in litigation to prevent me from obtaining adequate counsel. Although they have known of the mortgage fraud since 12/2018. Pursuant to NRS 205.365 is Rena Hughes, Bobby Antee, and Grayson Moulton sell my home without my consent, they are committing a Category D felony and the AG needs to prosecute. Pursuant to NCJC Rule 2.2 a Judge must remain impartial and fair, in which Rena Hughes failed to do. Rena Hughs then fabricated her ruling to conseal the Forgery and fraud committed by Nikki Bott and Linda Naw, which her consealment makes her part of Mortgage Fraud, in which she has no immunity when comitting criminal acts. Pursant to NCJC Rule 2.3 (a) (b) (c) a judge must refrain from allowing lawyers to harrass litigants, in which she allowed Shumway Van and Jennings and Fulton to harrass and defraud me, by litigating a divorce when she recived clear and conside evidence in 12/2018 that Fraud and Forgery has occurred. Jennings and Fulton and Shumway Van then went to trial where they unjustly enriched for pointless litigation, then removed all of my evidence out of the trial binder that had bee on file for over a year. They then turned in no evidence given to them or witnesses, but allowed Linda Naw to tesify and sit in on trial D-18-573154-D even though they were litigating case A-18-786141-C over the same matter, Jennings and Fulton knew Bobby Antee and Linda Naw were conspiring to conseal their actions and utilizing the same counsel which pursuant to NRPC Rule 1.8 imposed a clear conflict of interest. Every one has attempted to cover up this fraud for 3 years, in which no one has cared about me at all. I have been harrassed, slandered, and at times have felt suicidal from the torture I have experienced. I have now also obtained a letter from a handwriting expert which also confirms forgery, and is a clear sign of legal mal practice because I should have been told to do it prior to trial. Shumway Van and Jennings and Fulton have known for 2 years of Mortgage Fraud and continued to litigate and lie. I want the Attorney General to take action. I have reported it to every agency possible, even Deborah Conway the County recorder knew of the fraud and refused to revoke the deed. The lawyers have broken the law numerous times Rule 2.9 (a) states a judge must not have communications that arent disclosed to all parties. In which Rena Hughes continues to have Ex Parte Communications which I have filed Fraud on the Court which means any order entered by Rena Hughes is not vaild and pursuant to NRJC Rule 2.11 (a) (1) she should have recused herself, which she refuses. I have submitted evidence to contradict her ruling and she has refused to correct it knowingly interfering with Commerce Interstate, in which she has no ammnity. Elizabeth Gonzales then Dismissed cased A-20-808737-C in which she saw the clear legal malpractice of Jennings and Fulton and did not report them or Rena Hughes as required by Rule 2.15. I would like to stop getting the run around and Attorney General act and prosecute all involved.
