## Incident Description

In May of 2020, I caught judge Rena Hughes, Chris Tillman, Adam Fulton, Logan Wilson, Jared Jennings, Grayson Moulton, and Bobby ANtee committing fraud and conspiring to conceal mortgage fraud committed against me on January 17, 2018. In December of 2018 I submitted clear evidence of Nikki Sikalis Bott Escrow agent for National title company, notarized a quit claim deed that I did not sign. After catching my legal counsel, I began to file into my own cases, again providing proof of notary fraud and forgery, and in May of 2020 obtained a Letter from an expert confirming forgery. Shumway Van who represented both Bobby ANtee and Linda Naw, refused to accept that they had lost the case and began using corrupt judges and lawyers to continue their attacks. I reported this to the attorney general and the attacks became worse, as judge after judge refused to uphold my rights and began to steal equity from my home through fabricated orders. I filed for writ of arrest for Bobby, Linda, Niki Bott, and Melanie Treanor, in which the corruption in Nevada has protected them and allowed them to publicly attack me on social media. Posting my personal information, slander, and attacking my nonprofit organization to conceal the misconduct of each judge, government worker, and the lvmpd who refused to investigate this when reported to them in June of 2018. Bobby Antee, Nikki Bott, Linda Naw, and Grayson Moulton have created a page on Instagram called @lindseylicarifraudulist2020 which was made with the intent to defraud and harm me, and my charity work. Shumway Van, Linda Naw, Bobby Antee have now stalked me and my work for 3 years to conceal the crimes they have committed against me. Now another woman Holly Hopkins, who I have never met, from the UK is also posting items from this matter, slandering my work, and posting that I buy sex, which again is untrue. They are now contacting people who follow and support me harassing them and trying to destroy my work to conceal this fraud.

**Narrative**

On Nov 3rd 2017, I lost my son Ayden Brown to Cancer. On Nov 25, in a vulnerable state married Bobby Antee. We began to buy a home with the agreement that we would both be on the title of the home. as a married couple, and in turn I would provide the deposit. After finding a home, and realtor Linda Naw Perdue, I began to distrust Bobby, Linda, and no longer wanted the home. I canceled in writing to Linda Naw. On January 17, 2017, Bobby Antee, Linda Naw Perdue with ERA Brokers, Nikki Siklais Bott with National Title Company, Melissa Parker with one Realty group, and Drew Levey with Valley West Mortgage all held a fraudulent closing and conveyed title into Bobby Antee's name. They then had Nikki Siklais Bott who acted as the escrow agent, notarize the forged quit claim deed, producing my forged signature, which I have confirmed with a court and board certified expert, Curt Bagget. Melanie Treanor, the neighbor of Nikki Bott then Fraudulently Notarized the remaining loan docs into Bobby Antees name. I asked for annulment the next day, in which bobby antee refused and then conspired with realtor Linda Naw to continue to defraud me, using her legal counsel Shumway Van who is still representing both clients, and continues to stalk and harrass me endlessly. I reported this fraud in 2018 to LVMPD, NSOS, GLVAR, and Business and Industry, in which they all concealed the notary fraud and used my counsel, Chris Tillman, Jennings and Fulton, and Judge Rena Hughes to litigate this invalid deed for 3 years over a 60 day marriage. I caught everyone at the divorce trail in Feb of 2020 when I obtained the expert and learned the deed wasnt even vailid, and since then have been slandered on instagram @lindseylicarifraudulist2020 a page created by bobby, linda and nikki, attacking me and my work, when they all should have been arrested and my rights protected . I had now had to close my office, and move out of nevada to protect myself, they began sitting outside my office and home.
