IV. Information About Your Grievance - Continued

I filed a insurance bond with Liberty Mutual, when I found out my name was forged to a Quit Claim deed. I filed the Claim in April of 2020, in which I provided clear and concise evidence that Nikki Sikalis Bott forged my name to a quit claim deed, and she was also the Escrow officer on the file in which she illegally notarized her own loan file, making the Deed invalid. I provided Brandon Baines with a Letter of Opinion from A Forensic Handwriting Expert, Curt Baggett, and I also provided him with information from Nevada Secretary Of State proving Nikki Sikalis Bott did not turn in the journal in question, again confirming that my name was forged to the quit claim. Brandon Baines, who I do not even believe works for Liberty Mutual then instructed the Surety Claims Agent Clarisa Nail to commit further fraud, by denying my bond claim that I was fully entitled to. information of Legal Malpractice being committed by Jennings and Fulton Law Firm and Shumway Van Law Firm, yet did not report the malpractice at all, but also joined them in trying to conceal evidence.
